FWSA Ski Week Steamboat 2019 Report from Barbara Bousum

As previously reported, our 36 pillows were filled for Steamboat, and we added 4 more. I am waiting for payments to arrive from 2 more men, who will fill our last spot, as well as replace someone who must cancel. At this time, the full amenities package + lift tickets should be fully paid by each participant. \$45,546 has been collected and deposited to date. Once the last two participants have paid, we will have filled all 40 pillows. I do not anticipate adding any more pillows; late sign-ups can fill openings in other councils' available pillows or be on a waiting list. Our next payment to FWSA is due in early November, and the funds have been collected, so NWSCC is not fronting the \$\$ for the trip. Any cancellations now must fill their own spots. An updated replacement flier should be posted on the website soon.
