# Meeting Minutes January 26, 2021 ZOOM Video/Conference Call

**2022 Far West Ski Week, Aspen/Snowmass, Colorado**: Date for the event is January 22 – 29, 2022. Rod announced that Northwest's lodging allocation will be at Interlude Condos in Snowmass (our first choice). We were assigned 32 pillows. All pillows are in 2 bedroom units. - 1. NorthWest Ski Club Council Facebook Admin Support group. I am reaching out to the other ski club admins for input what they would like to see discussed this season. There was a lot of interest at first but very little participation. I am hoping to get some feedback of what will help them. Meanwhile, I will continue to post NWSCC news, shared trips & events, best practices in clubs and creating enthusiasm for their own ski clubs. Note: about half of the ski clubs within NorthWest Ski Club Council are not posting on their Facebook pages this season.
